## **EMERGENCY OVERVIEW:**

Ethyl Alcohol is Flammable Liquid and Vapor. Harmful if swallowed or inhaled. Causes Irritation to Eyes and Respiratory Tract. Affects Central Nervous System. May Be Harmful if Absorbed Through Skin. May Cause Irritation to Skin

## POTENTIAL ACUTE HEALTH EFFECTS:

Inhalation:	Breathing in small amounts of this material during normal handling is not likely to cause harmful effects.
